- Agency/Third-Party Funding
- Pay In Full (Buy-In)
- Payment Plan -Down payment is required to secure your seat, monthly payments are calculated and the student pays a set amount throughout their program. The total amount of the program will need to be paid before the student receives their certificate of completion.

Failure to secure funding for the program 30 days before the program start date will put students at risk of being dropped from courses due to non-payment

The Certificate of Competency (CCT) in Construction Trades: Electrical Commercial and Residential program is designed to provide knowledge, safety, and skills in the electrical construction trade. This program reinforces common construction skills to include the use of tools, adherence to safety and codes, and reading construction drawings. This award offers further theory and practice in commercial and specialty electrical, including work with electric power distribution, motors, and motor controls, specialty electrical lighting and services, and electrical currents. Students can seek employment as electrical technicians on residential and commercial job sites. A Certificate of Completion (CCL) and an Associate in Applied Science in Construction Trades are also available.
