#### **APPLICATION PROCESS**

- **<u>STEP 1</u>** Read this entire packet carefully
- **STEP 2-** Attend a virtual information session link found on the program website (<u>https://www.gatewaycc.edu/degrees-certificates/physical-therapist-assisting</u>) Contact a college healthcare advisor to discuss questions after attending the info session
- **STEP 3** Complete the steps to get admitted at GateWay <u>https://www.gatewaycc.edu/enroll/enrollment-steps</u>
- <u>STEP 4</u> Transcripts Request official transcripts from colleges/universities to be sent to transcripts@gatewaycc.edu
- **STEP 5** Complete pre-requisites (see page 10). Review points system for admission to the program on page 7. See page 13 regarding the required work/observation experience. Pages 14-16 should be submitted to the Admissions and Records by the clinical site where the work/observation experience occurred upon completion of the experience.
- **<u>STEP 6</u>** Submit the <u>**COMPLETED**</u> application (page 17-18) to the Admissions and Records Department July 1 – November 1 for the hybrid weekend program and December 1 – April 1 for the day program.

#### A completed application packet consists of:

- 1. Official college/university transcripts received by GWCC Admissions and Records.
- 2. Documentation of completion of ENG101 or ENG102 and BIO160 or BIO201 with a minimum grade of B in each course.
- 3. Documentation of HESI PTA Program scores with 70% or higher on each section within the last 2 years. (TEAS will also be accepted)
- 4. Completed verification of work experience/observation of 40 hrs. (SEE PAGES 14-16)
- 5. Completed application to program (SEE PAGES 17-18)

#### FREQUENTLY ASKED QUESTIONS ABOUT CAREERS IN PHYSICAL THERAPY

#### What is Physical Therapy?

Physical therapy (PT) is the art and science of providing care to patients suffering from injury or disease which has resulted in a loss of motion in the joints of the body, a loss of strength in muscles, increased pain, an inability to walk normally, as well any of several other examples of losses of physical function. Through physical therapy, patients work to regain the ability to function at their highest possible level. Patients may include infants, children, adults, and the elderly.

#### Who provides Physical Therapy?

Physical therapists (PTs) evaluate patients, determine what treatment is necessary, and perform skilled treatments. Physical therapist assistants (PTAs) help the physical therapist by performing selected treatment interventions with patients. PTAs are always supervised by PTs.

I really want to become a physical therapist – do I need to become a physical therapist assistant first? No, it is not necessary to complete education as a PTA to become a PT.

#### What Education is Necessary?

Individuals interested in becoming physical therapists complete a bachelor's degree prior to making an application to enter a doctoral educational program. Physical therapist assistants attend community or technical colleges that offer an associate's degree. Programs can be completed in 4-5 semesters.

#### Where do PTs and PTAs work?

PTs and PTAs are employed in hospitals, skilled nursing facilities, schools, home health and outpatient practice settings.

#### How much money do PTs and PTAs make?

#### What is the current job market for PTAs?

The United States Department of Labor/Bureau of Labor Statistics states, "Overall employment of physical therapist assistants and aides is projected to grow 26 percent from 2018 to 2028, much faster than the average for all occupations. Demand for physical therapy is expected to increase in response to the healthcare needs of an older population and individuals with chronic conditions, such as diabetes and obesity." Graduates of the PTA Program at GateWay Community College are currently in high demand.

#### Why should I consider a career in physical therapy?

A career in physical therapy is very rewarding. Each day physical therapists and physical therapist assistants work closely with their patients to help them recover from injuries or illnesses that have temporarily or permanently changed their lives. PTs and PTAs are important members of the rehabilitation team. Helping people to progress back towards optimal health is a wonderful experience.

#### Do I need to pass an examination to be a PT or PTA?

To hold the title of physical therapist or physical therapist assistant in Arizona an individual must pass the National Physical Therapy Examination (NPTE) for the respective level of education and training. The examination is administered by the Federation of State Boards of Physical Therapy (FSBPT). Costs associated with applying for licensure/certification and taking the examination are approximately \$650.

#### If I have a criminal record, will that prohibit me from being successful in this career?

Clinical agreements with healthcare facilities require that students possess a Level 1 Fingerprint Clearance Card issued by the Arizona Department of Public Safety and Background check through American DataBank. Additionally, a student must not be listed on the Federal Government's Office of the Inspector General's Exclusion List. #### FREQUENTLY ASKED QUESTIONS ABOUT THE PROGRAM

#### How many students are admitted to the program?

A new class of 24 students is admitted each August to the traditional day program. The weekend/hybrid education program admits a new class of 20 students in May of each year. The number of students admitted may change depending on employment market conditions and the availability of clinical training sites.

#### What do I need to do to apply to the program?

It is recommended that interested students contact a college advisor to discuss the program, attend a virtual information session to make an appointment. PTA faculty are also frequently available for consultation. Following these initial meetings, students should then work to complete the following:

- a) BIO160 (or BIO201) minimum grade of B required
- b) ENG101 or ENG102 minimum grade of B required
- c) TEAS or HESI Exam PTA Program within last 2 years- minimum 70% on all sections
- d) 40 hours of work/observation experience in physical therapy with a minimum of 10 hours in an inpatient (hospital, skilled nursing care, etc.) facility. Interested applicants are encouraged to allow adequate time to complete this requirement. It may take some time to locate a site, establish a schedule, and complete the required hours.

The above requirements **MUST** be completed prior to applying to the program.

#### What happens to my application if I am not accepted into the program?

The prospective applicant will need to reapply for admission into the program during the next application cycle.

#### How long does it take to complete the program?

The program can be completed in five semesters. Many students take a year prior to beginning the program to complete prerequisites and general education courses that are required for the Associate in Applied Science (AAS) degree.

#### Are the PTA Program courses transferable to colleges or universities if I decide to pursue a bachelor's

**degree?** Certain bachelor's degree programs will accept up to 90 credits from the program. Contact college advising for further information.

#### When are the classes scheduled?

For the day program, lecture and lab classes may be scheduled Monday through Friday. Classes may begin as early as 7:00 a.m. and end as late as 5:30 p.m. Depending on the semester, students may be in class for 3-6 hours per day, 3-4 days per week. For the weekend/hybrid education program lecture courses will be online with periodic on campus testing. Lab classes will be scheduled Friday, Saturday and Sunday, 7:30 a.m. to 5:00 or 5:30 p.m. All the lab classes are held on site at GateWay Community College. There are approximately 20 weekends of required on campus attendance for lab classes in the hybrid program.

Clinical practicum classes (PTA 206, PTA 280, and PTA 290) are generally Monday through Friday 40 hours per week for six consecutive weeks with some clinical sites requiring weekends. These classes require attendance at clinical facilities that include hospitals, extended care facilities, and outpatient practices.

#### What facilities do I contact to complete my volunteer/work experience?

Applicants are encouraged to contact local hospitals, nursing homes, and private physical therapy offices to arrange for observation experience. The program requires that 40 hours of observation or work experience must be completed prior to entering the program. A minimum of 10 hours must be completed at an inpatient (hospital, skilled nursing care, etc.) facility. For volunteer experiences, this requirement will often involve observing physical therapy practice without any direct patient interaction. Receiving physical therapy for a personal injury or medical condition will not be considered as part of the observation experience requirement.

#### Can I work and go to school?

For the day and hybrid/weekend education programs, applicants are cautioned that the PTA Program is a rigorous course of study. The program faculty recommends that work hours be kept to a minimum. Each student must make an individual decision about the number of work hours that they can handle while continuing to make acceptable academic progress in the program.

#### Is financial aid available?

Financial assistance is available to eligible students in the form of grants, scholarships, employment, or loans. Students may receive aid from one funding source or aid may be offered in a package from multiple sources. #### Does the weekend/hybrid education program have special requirements?

Students in the weekend/hybrid education program will need regular access to a computer with internet capabilities (high speed service is preferred). Students will be traveling to GateWay on various weekends and thus reliable motor vehicle transportation is essential. Students in this education program who travel from a distance will need to make their own lodging arrangements for the weekend lab classes. Every effort will be made to place students in their local communities for clinical education rotations. If this is not possible students may be required to drive many miles to the nearest available clinical site. Please note that only students who are considered residents of Arizona are eligible to take online classes in the weekend/hybrid program. Contact the Admissions and Records office regarding residency requirements.

### Once I start the program, can I transfer from the hybrid program to the day program or from the day program to the hybrid program?

Requests to transfer from one program to the other will be considered on a case-by-case basis. Transfer may not be possible due to a variety of reasons.

#### SELECTIVE ANNUAL ADMISSION PROCESS

Applicants for the Physical Therapist Assistant Program at GateWay Community College will be ranked on a point- based system. The criteria listed below will be used in the ranking process. Applicants for the program will be selected based on the points earned.

Applications for the hybrid weekend program will be accepted from July 1 through November 1. Applicants will be notified of their status by November 15. Late applications may be considered for admission if additional spaces remain in the program after the initial acceptance process has been completed. The hybrid weekend program starts in mid-May.

Applications for the day program will be accepted from December 1 through April 1. Applicants will be notified of their status by April 15. Late applications may be considered for admission if additional spaces remain in the program after the initial acceptance process is completed. The traditional day program starts in mid-August.

Any applicant that is not accepted but remains interested in the program will be required to reapply for admission during the next application period.

- 1. Grade in BIO160 or BIO201 must earn 2 points in this category
  - a. A = 4 points
  - b. B = 2 points
  - c. C, D or F = application will not be considered
- 2. Grade in ENG101 or ENG102 must earn 1 point in this category
  - a. A = 2 points
  - b. B = 1 points
  - c. C, D or F = application will not be considered
- 3. Score on HESI for PTA Program or TEAS within the last 2 years- must earn 21 points in this category
  - a. 10% of the score in each category is added as points
    - i. i.e. score 89.5% on math = 8.95 points, 70.1% on English composition= 7.01points, and 75.3% on anatomy and physiology= 7.53 points.
  - b. HESI scores below 70% = application may be considered if only one category is below 70% and there is additional space in the program one month prior to classes starting.
- 4. Work or observation experience in physical therapy submit required verification form(s) must earn 1 point from this category. (10 hours of work/observation experience must be from an inpatient facility)
  - a. Work experience as a physical therapy aide/technician 2080+ hours = 3 points
  - b. Work experience as a physical therapy aide/technician 1040 to 2079 hours = 2 points
    c. 40 or more hours of observation experience in a physical therapy practice OR 40-
- 1039 hours of work experience as a physical therapy aide/technician = 1 point 5. Completion of general education requirements (ENG102, MAT, COM, HCC146 or
- HCC 145, PSY101, Humanities, CRE) with a minimum grade of C in each course.
  - a. 7 courses completed = 3 points
  - b. 3-6 courses completed = 2 points
  - c. 1-2 courses completed = 1 point
- 6. Work/volunteer recommendation rating
  - a. Cumulative average of 9.5 to 10 = 3 points
  - b. Cumulative average of 8.5 to 9.49 = 2 points
  - c. Cumulative average of 7.5 to 8.49 = 1 point
  - d. Cumulative average of 0 to 7.49 = 0 points
- 7. AA degree or higher 1 point

#### IMMUNIZATIONS, TESTING, AND BACKGROUND REQUIREMENTS

#### Immunization and TB Testing Requirements

Once a student has been accepted into a program for the start of an upcoming semester, clinical requirements will be sent out. All health and safety documentation are submitted digitally. The health and safety requirements are subject to change based on the requirements of our clinical partners.

#### **MCCCD Background Check Policy Requirements**

Students will receive Information regarding the MCCCD Background Check after admission, but prior to the beginning of the program. Students admitted to an MCCCD Allied Health or Nursing Program (Program) will be required to obtain a valid Level-One Arizona Department of Public Safety Fingerprint Clearance Card (FCC Card) AND a passing score on an MCCCD background check. This policy precludes MCCCD faculty or staff from assigning students to a clinical experience who cannot meet the new requirements.

Students bear the financial costs for both the MCCCD Background Check and the AZ Fingerprint Clearance Card. The card is valid for six years from the date of issue.

#### **Drug Screening**

Each student must go through a preclinical drug screen prior to beginning the first clinical rotation. Drug screening for all Physical Therapist Assisting students is mandatory. The cost for tests will be the responsibility of the student. The urine drug screen will test for alcoholic beverages; illegal drugs, or drugs that may impair judgment while in the clinical agency. If the drug test is positive for the illegal drugs or undocumented prescription drugs, the student will not be able to continue in the program. Medical marijuana or its metabolite is not an acceptable substance in drug screens. Readmission is at the discretion of the college and the program. Some clinical sites also require additional drug screening.

#### ESTIMATED PROGRAM COSTS

The estimated cost for the program is outlined in the chart below. The student is responsible for providing transportation, housing, and uniforms.

#### ESSENTIAL FUNCTIONS

The following is a list of physical/mental requirements that are expected of students in the Physical Therapist Assistant Program.

- 1. Demonstrate visual acuity and auditory ability to assess the condition of a patient and administer effective patient care.
- 2. Demonstrate manual dexterity, eye-hand coordination, fine and gross motor skills, and tactile abilities to perform functions as directed by the physical therapist and in accordance with skills outlined in section three of the Evaluative Criteria for the Accreditation of Physical Therapist Assistant Education Programs (see attachment).
- 3. Demonstrate critical thinking and problem-solving skills for effective patient management and implementation of selected treatment interventions.
- 4. Maneuver equipment in a patient's room or in the physical therapy department in a time efficient manner.
- 5. Work in stressful situations that require quick thinking and the simultaneous coordination of a variety of activities.
- 6. Demonstrate physical agility to respond to patient and family needs, including unexpected changes in the patient's status.
- 7. Demonstrate the physical ability to assist patients in ambulating, positioning in bed, and transferring from the bed/mat, wheelchair, or car in a time efficient manner.
- 8. Demonstrate proper body mechanics for lifting.
- 9. Lift objects more than 100 pounds with assistance with frequent lifting and/or carrying objects weighing 50 pounds or more.
- 10. Tolerate prolonged standing, stooping, squatting, bending, pushing, and pulling.
- 11. Demonstrate ability to read, write, understand, and speak English.
- 12. Demonstrate effective verbal and non-verbal communication skills with internal and external customers.

Students who are unable to perform these functions, with or without reasonable accommodations, may be unsafe in the clinical environment and thus will likely be unsuccessful in the program.

#### WORK / OBSERVATION HOURS

Applicants must complete 40 hours of work/observation in physical therapy settings before applying to the PTA Program, including at least 10 hours in an inpatient facility (hospital, skilled nursing, or rehab hospital). This ensures applicants understand PTA job duties and are committed to the career.

Most facilities only allow observation, not hands-on experience. Hours can be completed in hospitals, rehab centers, private practices, schools, or agencies. Students are responsible for arranging their own observation hours, which may require contacting multiple facilities and completing orientation.

A physical therapist or PTA must certify completed hours using the Work/Observation Hours Verification and Assessment Form. Personal physical therapy experience does not count toward this requirement.
